The Committee shall have the authority to:


- Manage and administer the affairs, funds, and related work of the Association.

## 7. Rules and Regulations:

#### **These Rules and Regulations shall cover:**

- All the decisions of the committee should be taken unanimously.
- Secretary should prepare minutes of all the meetings.
- Notice of the meeting should be given to the members before seven Days of the meeting.
- If any of the Committee member wants to resign, then the respective member should give the Notice of resignation to the committee one month before the date of resignation.
- To fill the vacancy of retired member the Committee should issue notice at least seven days before filling the appointment.
- Quorum of meeting should be Two-Third of the members present and voting.

## 8. Meetings:

The Committee shall meet monthly to conduct its operations. Meetings may be convened by the chairman or upon the request of a majority of committee members.

## 9. Financial Matters:

**Bank Accounts:** The Association shall open and maintain bank accounts in its name for the purpose of carrying out its activities. All funds shall be managed in accordance with decisions of the Committee and in compliance with applicable laws. The rights to operate bank account will be with Chairman, Secretary and Treasurer.


**Financial Year:** The financial year of the Association shall commence on 1<sup>st</sup> April and end on 31<sup>st</sup> March.
